Of this amount, \$83,895 was spent to conduct our annual Delegate Convention and \$63,087 was spent conducting Gather4Good events. Gather4Good is a volunteer, family oriented service project started in 2010 to assemble personal care kits for people in the local community experiencing homelessness.

In accordance with our mission to support the Roman Catholic Church in extending the faith, commanding and encouraging Catholic schools and religious education, Fraternal benefits totaling \$515,677 were spent during the year. Of this total, \$283,367 was provided to Catholic Dioceses and parishes, \$60,141 was granted to organizations supportive of extending Catholic teachings and \$171,169 was spent supporting Catholic education, including the Annual Catholic Schools Raffle. This Raffle has raised over \$3 million for over 100 Catholic schools since its inception five years ago.
