Patient Care The Foundation raises money to support Gillette's patient-care needs In 2013, the largest amount of money raised for patient care went toward financial assistance and charity care to patients Gillette offers financial aid to those who need it, whether or not they have health insurance and charity care for patients who are financially unable to pay all or part of their medical bills See Schedule O Gillette evaluates each situation based on a patient's income, assets and other resources, and the hospital helps patients set up manageable payment plans (including co-pays and co-insurance) For people who don't have insurance, Gillette charges for care in accordance with the 501(r) guidelines If patients inform Gillette that they will have a difficult time meeting their financial obligations, Gillette will try to qualify patients for public assistance or Gillette's charity care program Income eligibility for Gillette's program is based on national poverty guidelines In addition, this fundraising area provides charitable support to the many areas of Gillette's operations that are unreimbursed or under-reimbursed by third-party payers For example, Gillette holds Outreach Clinics in 16 communities in greater Minnesota The Outreach Clinics offer services from doctors, nurse practitioners, seating and adaptive equipment specialists, and rehabilitation engineering technologists, providing patients with more convenient and timely health care appointments They also enhance the knowledge base of community providers and improve the quality of ongoing care available in greater Minnesota Gillette increased its number of Outreach Clinics visits by 30% over 2012 Gillette also provides a variety of services to patients through our Child and Family Services area Child life specialists help children and families prepare for and cope with hospital stays and medical procedures We offer play therapy, music therapy and positive distractions to help patients understand their health-care experiences and overcome fear and anxiety Social workers provide emotional support and help with practical concerns for families of children who have disabilities, such as ordering medical equipment and finding transportation or other resources Therapeutic recreation specialists help Gillette patients develop healthy lifestyles and Gillette Lifetime Specialty Healthcare offers services for patients 16 and older who have conditions that began during childhood and require lifelong specialty care We treat the age-related effects of cerebral palsy, epilepsy, spina bifida and neuromuscular conditions

Capital The Foundation raises money to support Gillette in providing specialty health care for people who have disabilities In 2013, the Foundation completed fundraising (through outright gifts and pledges) to help pay off our capital expansion projects, which were finished in 2013 That expansion included a new outpatient services building on our St Paul campus, expanded space for Rehabilitation Therapies and the James R Gage Center for Gait and Motion Analysis, expanded surgery suites and a surgery waiting area, a surgery simulation center for training, and renovated inpatient facilities in St Paul

Research/Other The Foundation also raises money to support Gillette's ongoing research projects and education programs During 2013, Gillette researchers focused on studies related to neurosciences, orthopedics, pain and motion analysis For example, one study looked at long term follow-up of people who have cerebral palsy and who have undergone selective dorsal rhizotomy surgery The study compared the differences in outcomes between those patients and patient who had alternative treatments See Schedule O One of the primary Foundation grants in the area of education involved funding an academically affiliated spasticity management fellowship The fellowship helps prepare physicians who are highly qualified in spasticity management to incorporate spasticity management therapies (including, but not limited to, intrathecal baclofen therapy) into their clinical practices

Gillette's direct response program strategy is twofold: 1) to acquire new donors at an acceptable new donor investment level and 2) to increase the number of donors who support the Foundation year over year and create positive giving relationships with those donors. Gillette is measuring and seeing improvement in both of these strategic initiatives. SFI Nonprofit is a telefundraising firm that Gillette retains to execute a telefundraising program. We use telefundraising to gain additional gifts from current donors at a net profit. We also use telefundraising to acquire new donors, an investment we intentionally make in order to increase the number of people donating to Gillette. This is a necessary investment to raise even more money in future years.

The external consultant has provided an opinion that the CEO/president's total compensation is well within the standards of reasonableness and fair market value. In addition to the oversight function of executive total compensation, the personnel committee oversees any payments under any incentive compensation plans and evaluates all transactions with "disqualified persons."
