BASIC LIFE SERVICES OPERATES NINE FOOD SHELVES AND TWO FOOD PARTNERSHIPS. EACH FOOD SHELF IS OPEN EXTENDED HOURS, MULTIPLE DAYS PER WEEK TO HELP STABILIZE THOSE WHO ARE STRUGGLING TO MAKE ENDS MEET. ADVOCACY IS OFFERED TO CLIENTS TO HELP THEM CONNECT WITH OTHER AVAILABLE COMMUNITY RESOURCES. OF NOTE IN 2013, BASIC LIFE SERVICES DISTRIBUTED 2.3 MILLION POUNDS OF FOOD AND PERSONAL CARE ITEMS DURING 25,508 FAMILY APPOINTMENTS, BUILT CAPACITY TO SERVE MORE PEOPLE IN NEED, DISTRIBUTED SUPPLEMENTAL SUMMER LUNCH MEALS TO 1,300 CHILDREN AND SUPPLEMENTAL WEEKEND MEALS TO 156 CHILDREN, PROVIDED 1,428 HOUSEHOLDS WITH THE FIXINGS FOR A HOLIDAY MEAL, AND HELD A WEEKLY FREE COMMUNITY MEAL.

THE TEEN CENTERS PROVIDES A SAFE GATHERING PLACE FOR LOCAL YOUTH AND THE MENTORING PROGRAMS PROVIDE ONE-ON-ONE SUPPORT FOR SUCCESS.
