Part XII 2C: Oversight of the books remains the same as in past years. The bookkeeper of the center is a volunteer and is on the board of directors and serves in the capacity of treasurer. Being a volunteer, the work is done off the campus of the center in his own personal office. The office manager and the executive director work together in making deposits for the center and they also pay all the center's bills. At the end of the month they send a spreadsheet to the treasurer and all transactions are entered into the books. On the 15th and EOM hours are forwarded to the treasurer and payroll is paid. The treasurer is then in charge to file all Federal and State withholdings required by law for each month, quarter, and annually. The board of directors meet every odd month and a detailed financial report is given to each member present at the meetings. Using this process, there are three different people working with the books and the board of directors feel that there is a very high accountability of records and that the books are accurate.
