

**Distributed \$129,400 to other non-profit organizations for their distribution to individuals and families in need of food, shelter and clothing. Additionally, we honored 214 free merchandise vouchers (valued up to \$10 each) issued by these organizations.**

Through the annual survey of the organizations, over 15,600 individuals and 6,600 families were assisted in 2013.

Included in the \$129,400 total distributed are \$48,000 given to the local food shelves, \$12,000 for the Christmas and Thanksgiving food baskets for the needy. The remainder was given to other local agencies such as church benevolent fund; homeless abused women housing, food, clothing programs; pregnancy related food and clothing programs for mother and child, and drug recovery in-house food and shelter programs.

The recipients listed received funds for distribution to families and individuals in need of assistance. The Board of Directors reviews requests for funding and by majority vote, approves funding at specified limits.

Annually, the organizations must report to Shalom how the funds received were used, and provide a count of families and individuals assisted. In 2013, because of our funding and other funds received, over 6,600 families and 15,600 individuals received assistance.
