Thirteen were evicted for violating sober lease, eleven moved into permanent housing, and the remaining 16 carried over to 2014 at Freedom Place 2. We provided employment and training to 23 clients who were paid \$54,662.75 in total payroll during 2013. Clients either worked in the office, canvassing, or doing remodeling and maintenance on the four homes we use for housing. 3 Major rehab projects in 2013: A) Installed a new chain link fence for \$2,000 at 653 Dale to add additional security at the property. B) We reinforced and repaired the foundation at 600 Van Buren for \$1,500 to water proof the basement. C) We paid a plumbing and heating contractor \$3,000 to install three new radiators at two different homes to keep them well heated during the winter. D) We paid a contractor \$2,000 to restore a concrete retaining wall and put hand rails on the steps in front and the back of the home at 52 Jessamine. 4 This spring we operated an organic garden for the 21st straight year that provided produce and vegetables for our clients at 404 Charles.
