Discussed with citizens and members their concerns over rising health care costs and cost inefficiencies and unaccountability in the current delivery system. Updated them on activities that addressed their concerns, and informed them of ways they can engage in the policy-making process on these issues.

In Central Minnesota visited main street businesses, family farms, and rural residents to hear their concerns over unaffordable high deductibles and the current system's unaccountability for their premium and tax dollars which were addressed at the annual Farm Picnic. Members worked with faith-based groups in Central Minnesota and with coalition physicians to organize and conduct public forums to compare the single-payer standards of cost efficiency and public accountability to the market-based state health insurance exchange.
Worked with the Brainerd area League of Women Voters and a prominent state historian to present a forum on the role of citizens in affecting social change throughout Minnesota's history.

Using initial information from a farmer member, initiated research on the state's granting of inappropriate exemptions to the state's corporate farm law for certain ag operations that negatively impact family farms and the local economy. Informed farm co-op boards and farmers of these inappropriate exemptions to help them prepare a recommendation to the state department of agriculture for proper protocol for the granting of future exemptions.
