Winona Area Ambulance Service, Inc. responded to approximately 3,332 calls in 2013, of which 2,512 were transported for medical services. We are an advanced life support service that provides coverage for approximately 100 square miles, including the cities of Winona, Goodview, MN, and surrounding communities in Minnesota and Wisconsin. We provide 911 coverage, non-emergency calls, transfers, standbys and intercepts for surrounding basic life support services. We also provide training and continuing education for area emergency responders and healthcare providers.
