Promoting solidarity and cultural exchange across borders between the people of El Salvador and others in the search for development and dignity. The mission of Los Olivos CIS is carried out primarily via program grants to the Center for Interchange and Solidarity (CIS) in El Salvador

Civil rights, democratic and community development, emergency aid, and advocacy programs - CIS promotes grassroots organizing in various communities. Twenty-seven community organizations currently make up the "Community Network for Cooperation and Solidarity." CIS plays a role in the campaign for water rights, food security and sovereignty, and against damaging metallic mining. The CIS also supports educational campaigns of SIGESAL, the public hospital workers association for medical reform and workers rights, and legalization of land titles. CIS provides "accompaniment" for several communities, assisting with community benefit projects such as land legalization, electricity, computer workshops, community kitchens, latrines, and solar energy. CLEAN WATER is currently a major focus of CIS community assistance efforts. 464 Sawyer water filters were distributed to 14 communities in 2013 and a total of 943 filters to 24 communities since we began the program in 2011. The CIS clean water campaign not only distributes filters and teaches families how to use and maintain them; we also do a two-day training on the environment, health, and water prior to the distribution. Through an agreement with Clean Water for the World (CW4W), we also installed six industrial water purification units, primarily in educational centers. Youth formation and Scholarship Programs - provides education to potential community leaders who would not be able to study without help and at the same time build their awareness of their role as agents for making changes for social justice. The CIS worked with 14 local Salvadoran committees and organizations and 17 sister organizations as well as individual donors to raise funds for 113 youth to go to the university and 197 to go to high school this year. Monthly leadership, formation and analysis sessions were organized for students and their parents by CIS community organizers. Scholarship recipients also carried out volunteer programs including community clean-ups, clean water campaign follow-up, tutoring grade school students in reading and writing, coordinating a health campaign with a clinic, and much more.

International cultural exchange and education: Educational delegations and language and cultural exchange. 25 international volunteers plus students majoring in English at the University of El Salvador taught English classes to 207 local community members during 4 nine-week terms. The volunteers also receive orientation to El Salvador and the empowerment work of CIS. CIS continues coordinating with the University of El Salvador to provide Salvadoran students majoring in English with an opportunity to practice their profession and fulfill their 500 hours of social work requirement by teaching at the CIS. 153 international participants received Spanish instruction and cultural orientation from local native speakers. The Spanish school staff also contribute to developing workshops with CIS promoters including water and environment with public school teachers, gender, and job search, among others. CIS hosted 13 delegations with 138 participants in 2013. Delegates visit El Salvador to gain an in-depth understanding of the social and economic reality of El Salvador. The delegation program also promotes solidarity with communities and grassroots organizations working for social and economic justice.
