Community Grants - MOFAS coordinates community grants programs to build the capacity of the state to prevent prenatal alcohol exposure and to identify and support individuals and their families who are living with this challenge. There were 16 grants in process in 2013. From those, 2,313 children were screened for prenatal alcohol exposure by their primary care provider. There were over 1,270 families, caregivers and individuals with FASD who received supportive services and educational opportunities in their communities. Additionally, there were 13 mental health professionals in the state who worked with 35 families to become certified in the FASD and mental health program, Families Moving Forward.

Intervention and Family Support - Connecting families to resources and supports is the main goal of providing family support. Women at the greatest risk of having a child with an FASD were offered information, education and support through the Changing Course series. This series reached 550 women through 12 different recovery programs. There were also over 7,600 requests for information, support, encouragement and referrals that were responded to in 2013. In addition, parents connected online through the Virtual Family Center, where there were over 1,400 posts per month.

Public Awareness - To help make FASD more widely understood, MOFAS supported several statewide public awareness activities aimed at educating the general public and specific groups of people on the risks of drinking alcohol during pregnancy. In 2013, over 9,900 women of childbearing age received the 049 prevention message at 16 major events across the state. Over 130,000 pieces of public awareness/education materials were distributed through various programs and agencies throughout Minnesota.
