Exhibitions Over the past year, we originated 5 world premiere exhibitions from a diverse group of artists based in Minneapolis, Berlin, Glasgow, Brussels, San Paolo, Nova Scotia, New York, Tehran/Berlin, Frankfurt, and Vancouver These exhibitions presented the work of 13 artists Much of the work was commissioned by Midway, while in one group exhibition work was on loan from major museums and private collections from New York, Beirut, Brussels, Amsterdam, Berlin, and other cities These exhibitions received very positive reviews and coverage in local, national, and international press outlets - both trade industry and general public As part of this exhibition season, we also instituted a formal artist stipend policy that provides the artists in our solo exhibitions and the guest curators of our group exhibitions with \$5,000 as a fee in addition to covering all expenses related to the production, shipping, travel, per diem, and accommodations related to their exhibitions Public Programs In addition to exhibitions, our other programmatic efforts have been increasingly strong Thanks in part to project support from the National Endowment for the Arts, we have been able to offer our audiences an impressive lineup of public presentations Visitors such as the Carnegie International Curator Daniel Baumann, Swiss artists Tobias Madison and Kaspar Muller, Swedish artist Nina Canell, Chicago curator Dieter Roelstraete, and independent curator Fionn Meade have all presented lectures that have been met with enthusiasm, curiosity, and capacity crowds of up to 200 people Library One of the most exciting developments at Midway has been the success of our library Following a capital campaign funded largely by individuals, we raised \$45,000 and were able to expand the library this past year to meet our growing audience needs The library grew from 500 square feet to 1,250 We built brand new shelving that will enable us to grow the collection for the coming years, and added a new computer search station, a dedicated reading area, and new lighting
