

Girls on the Run is a transformational physical activity based positive youth development program for girls in 3rd-8th grade. We
teach life skills through dynamic, interactive lessons and running games. The program culminates with the girls being physically and
emotionally prepared to complete a celebratory 5k running event. The goal of the program is to unleash confidence through
accomplishment while establishing a lifetime appreciation of health and fitness

Girls on the Run Greater Houston held after-school programs serving 910 girls at 49 sites around the Greater Houston area. The
program combines an interactive curriculum and running to inspire self-respect and healthy lifestyles in pre-teen girls from 3rd to 8th
grade. 753 3rd-5th graders participated in the "Girls on the Run" program at 37 sites and 157 6th-8th grade girls participated in the
"Girls on Track" program at 12 sites. Of the 49 sites, 38 are Title 1 schools with a minimum of 40% of the students receiving free
lunches. 76% of the girls pay an average of \$25 for a program that costs nearly \$145 per girl. Each girl at a Title 1 school received a
pair of running shoes. GOTRGH gave nearly \$14,000 in running shoes to Title 1 girls in 2013. With the help of our generous donors
and sponsors, we are able to bring the Girls on the Run and Girls on Track programs to all schools, public, private, and charter, and
community centers in the Greater Houston area. Over 300 wonderful volunteers donated their time and effort to Girls on the Run
Greater Houston in 2013.

Girls on the Run Greater Houston held Spring and Fall 5K runs, the culmination of the program for the girls, in May 2013 and
December 2013. The goal is for participants to complete a 5K in a positive, encouraging environment. In May 2013 over 450 girls and
500 additional family members, volunteers, running buddies and runners celebrated the girls in the season-ending 5K at Uptown Park.
The true success of the program, however, is not told in the numbers, but rather in the words of the girls who participate. "Girls on
the Run made me realize that I am the boss of my brain." "I know that whatever I set my mind to do, I can do." "At Girls on the Run I
learned how to be comfortable in my own skin!" Girls on the Run honors its core values. We strive to:

- Recognize our power and responsibility to be intentional in our decision making
- Embrace our differences and find strength in our connectedness
- Express joy, optimism and gratitude through our words, thoughts and actions
- Nurture our physical, emotional and spiritual health
- Lead with an open heart and assume positive intent
- Stand up for ourselves and others
