



PUBLIC RELATIONS The Company supported 4-H activities with trophies, help with their community service programs. Hosted two Stroke Detection Plus screenings for members and community with 80 participants. Co-sponsored a tailgate event with the local FFA Chapter that reached 500 students and 600 game attendees with flyers and announcements at a cost of \$590. Hosted an annual meeting for all members to display and promote member benefits and activities of the organization. 99 attended at a cost of \$1,454. Sponsored a local cookout contest at County Fair, educating public on food safety and nutrition, promoting quality Iowa meat. Several hundred fair attendees stopped during the cookout contest. Supported the Benton County Cattlemen. News releases and letters to the editor about the Company and its activities and issues affecting agriculture.

EDUCATION The Company strongly supports agricultural education and has worked very hard at keeping local schools and students aware of how important agriculture is. The ways they have accomplished this is by providing scholarships to high school seniors for college tuition totalling \$1,000. Hosted a membership kickoff for 55 members to learn the benefits of memberships, growing membership grow & farm promotion. Participated with the 3rd Grade Ag Education Day for area schools. 325 third grade students in Benton County gathered at the county fairgrounds for a day of educational tours and informational booths. Participated in a Farm Safety Day Camp for 4th, 5th and 6th grade students in the area. Volunteers educated attendees about the hazards around the farm and promoted safety. Sponsored young farmers to attend the Iowa Farm Bureau Federation Young Farmer Conference. Supported the Dysart Historical Society's Ag Museum with many activities held for the public, school groups, 4-H and FFA groups throughout the year. Supported IDALS calendar drawing contest to 150 students.

POLICY DEVELOPMENT Members met several times (7) with elected state and national officials to discuss the importance to agriculture at a cost of \$700. Made numerous phone calls and sent many emails to state representatives and senators regarding issues important to farming such as electrical inspections. Met with county board of supervisors and county officials discussing budgets affecting the company's members. Committee formulated a survey for members. This was made available to all members and encouraged them to participate in the grassroots policy development process. Policy was written based on results of the survey for the ag communities.
