Through participating in this event, agencies are able to inform the public of the wonderful services they provide to Mahaska County residents. Community members can participate in our 5K Run/Walk and then celebrate with family and friends. We tailor the day towards families, as we know the importance of building strong family relationships. Prizes are given away, a free picnic lunch is provided, and fun is had by all.

In December 2013, United Way of Mahaska County began operation of a Volunteer Center. Through use of a Volunteer Website, Mahaska County agencies are able to post volunteer needs. Community members are able to search for volunteer opportunities. The Volunteer Center will promote volunteerism in our community and will be utilized by the local Blue Zones Project.

**Part III, Line 4d - Other Program Services**

**Designated Gifts:** Expenses - \$74,839 - United Way of Mahaska County accepts designated donations from donors during the annual fundraising campaign. Donations are forwarded to designated human service 501(c)3 agencies.

**Special Grants:** Expenses - \$23,080 - United Way of Mahaska County provided Special Grants to 8 local agencies in Mahaska County. Programs funded included helping pay for a new roof, office equipment, basic needs, and programming supplies.

**Operation Backpack:** Expenses - \$4,156 - Each fall, United Way of Mahaska County helps children of low income families by providing the necessary supplies for the upcoming school year. Any child, preschool through 12th grade, is eligible for assistance in this program. In 2013, we supplied over 500 backpacks to children in Mahaska County. Leftover school supplies were given to local schools to stock school supply closets to be utilized by teachers throughout the school year. We partnered with SIEDA, Love In the Name of Christ, Salvation Army and the school districts in Mahaska County.

**VITA Tax Site:** Expenses - \$2,137 - United Way of Mahaska County recruits volunteers, coordinates and hosts a VITA Tax Preparation Assistance Site. IRS Certified VITA Tax Preparers provide free tax preparation for low income families and individuals.

**Capacity Building Series:** Expenses - \$1,825 - United Way of Mahaska County hosted a series of seminars for its agencies and other local non-profits. These seminars were geared toward offering information to improve effectiveness in management of a small non-profit and provided an opportunity for local agencies to share ideas.

**Volunteer Center:** Expenses - \$659 - United Way of Mahaska County began operation of a Volunteer Center in December 2013. Local agencies will be able to post volunteer needs on the Volunteer Center website. Community members can access the website to find volunteer opportunities.

**Coat Drive:** Expenses - \$283 - United Way of Mahaska County provided promotional materials and supplies for the local Coat Drive, in partnership with New Hope Community Center.
