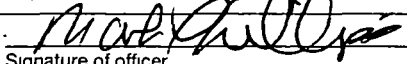

Regarding the use of comparability data, every three years, the board reviews the Human Capital Study conducted by United Way Worldwide as well as surveyed responses from similarly sized United Ways in the Midwest.
