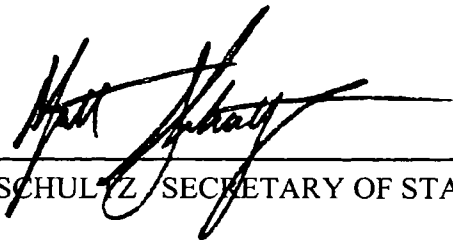
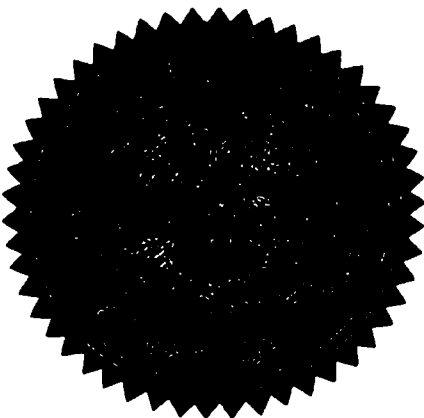

**TO THE SECRETARY OF STATE  
OF THE STATE OF IOWA:**

Pursuant to the provisions of Section 504.1005 of the Iowa Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I. The original name of the Corporation was St. Mark Community Center for Ministry. The effective date of its incorporation was the 3<sup>rd</sup> day of April, 1991. Articles of Amendment were filed with the Iowa Secretary of State on October 2, 1997, changing the name of the nonprofit corporation to: St. Mark Community Center. .

II. The following amendment of the Articles of Incorporation was adopted by the corporation:

- 1) The title is amended to read:

**ARTICLES OF INCORPORATION OF ST. MARK  
YOUTH ENRICHMENT.**

- 2) The first sentence of ARTICLE I is amended to read:

**The name of the corporation is St. Mark Youth  
Enrichment.**

III. Article IV of the original Articles of Incorporation and the amendments thereto is hereby deleted in its entirety, and replaced with the following new Article IV:

The Corporation is organized exclusively for charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, and in this connection, the purposes and missions for which the Corporation is formed, are as follows: The mission of St. Mark Youth Enrichment is to be a pro-active force supporting people in downtown Dubuque through ecumenical cooperation and community partnerships. The St. Mark Youth Enrichment will provide facilities, leadership, education and training necessary for children, youth, adults and families.

We are committed to:

- (1) identifying a broad range of unmet human needs of children and adults in this area;
- (2) recruiting people from the community who can help met those needs; and,

The Corporation shall have all powers set forth in Chapter 504A of the Code of Iowa that are reasonably necessary to fulfill and meet these purposes and which are not prohibited from being possessed or exercised by an organization exempt from income tax pursuant to Section 501 (a) of the Internal Revenue Code or by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

IV. The corporation has no members. The amendments set forth above were adopted by the Board of Directors at a meeting held on May 7, 2013. The amendments received the vote of the majority of the directors in office.

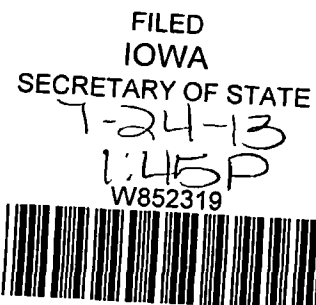
