and the end of the year in 2013. Retirement and Other Deferred Compensation for Carolyn Schmidt of \$103,233 consists of a

retention payment and the estimated change in the actuarial value of the defined pension benefit in the amount of \$49,900 and

\$53,333, respectively. The Board approved a retention plan for Carolyn Schmidt in 2009. Annual credits, specified at the inception

of the retention plan are paid annually. The retention plan is 100% at risk with payment contingent upon Schmidt remaining in the

Museum's employment on the credit dates. The amount of the retention credit in 2013 was \$49,900. Retirement and Other Deferred

Compensation for Linda Thomas, Paul Haner, and Bradley Haberer consist of the estimated change in the actuarial value of the

defined pension benefit in the amount of \$30,625, \$47,739, and \$72,129, respectively. Carl Hamm has not achieved service years to

vest in the pension plan, consequently, no estimate is made.
