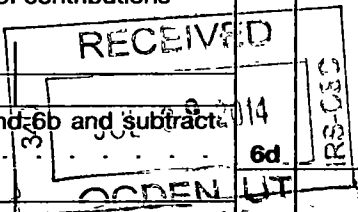




In 2013, we cooperated to sponsor a seminar for teachers of grades K1-K5 to follow up on a seminar in 2012 (introducing more creative teaching skills), and look forward to continuing these seminars and expanding future seminars to cover the upper grades.
