Nu-Vision Ministries Rwanda, 8363 Remera Box 2681, Kigali Rwanda. This years money went to the materials and building of the 4 dorms patio and work on a remodel of their great hall. 570 kids in the boarding school, 6th grade to 12th. They are one of the highest ranked schools in Rwanda. Also note we bought soccer, basket, volley balls, 2 fire blankets and light bulbs they couldn't there. Ministry also sponsors 28 rwandan children in schools (28 X \$300) \$7,600 of the funds went there. I annually visit them and I have received funds for my trip and they are in the other money I listed.
