Fargo Marathon, Inc. is a North Dakota nonprofit organization. The purpose of which is to promote the awareness of healthy and active lifestyles in people of all ages. A main focus of the organization is to donate a portion of the monies raised back to charities that focus on youth related causes. At the end of the year, Fargo Marathon Inc. owned four races: the Fargo Marathon, 81 on 81 Relay Run, Go Far Woman Run, and Fargo Mini Marathon. The ninth annual Fargo Marathon events were held May 16-18, 2013. Events included a youth run, 5K, 10K, half marathon, marathon relays, and a full marathon. There were approximately 24,000 participants across all events. The 81 on 81 Relay Run was held July 19-20, 2013. Events included 6 and 12-person relay teams across an 81 mile course. The inaugural Go Far Woman Run was held August 24, 2013. Events included a 5K, half marathon, and half marathon relay. There were approximately 1,500 participants across all events. The fifth annual Fargo Mini Marathon was held on October 19, 2013. Events included a 5K, 10K, and half marathon. There were approximately 2,000 participants across all events.
