 RLC provides clinical and pastoral counseling, fosters and cares for church pastors and their families and provides Spiritual Formation teaching, training and mentory to both church leaders and individuals. During the calendar year 2013 RLC provided 4487 counseling visits alone. This does not include the numerous students that particiapted in various classes and seminars RLC held in 2013. In addition, RLC provided \$256,191 in donated counseling services to those otherwise unable to pay.

 RLC had 4487 counseling visits in 2013 and of those visits RLC provided \$256,191 in donated counseling services to those who could not afford to pay for counseling or could only pay at a reduced rate based upon our established sliding fee scale. RLC continues to see a great need in the Las Vegas valley for counseling for both individuals and families. The stresses of daily life, family, marriage and occupational challenges continue present themselves in the clients we see. RLC has partnered with several care groups in town such as the Rescue Mission and the Walter Hoving Home who come alongside those who are homeless and have drug and alcohol challenges. RLC played an instrumental role in saving marriages and families during 2013 through ongoing counseling at the center.

 RLC continues to expand the Spiritual Formation program. We are currently offering classes in Transforming Lives and the Bible Institute. In addition, we have also recently added a special Spiritual Formation small group at the center. These classes are instrumental to our clients and members of the community so they can learn more about the bible and what it means to them and to reflect on their past and encourage a healthier future.
