FAWCO, The FAWCO Foundation and its member clubs raise money for a specific target project supporting one of the four areas of
interest - human rights, environment, health and education.

The target water project campaign was officially completed during the year 2012 and monies received through June 30, 2013 were
sent to "Wells for Clean Water", Cambodia. This campaign supported the environment.

The new target project will be supporting human rights and a specific project will be selected in 2014. Fund raising for this new
target program began in June 2013. Monies collected are held until the specific project is selected and then will be disbursed.
