It is and continues to be the position of the foundation and disqualified persons that the leases and rents paid pursuant to them were approved by the Service, that the Service was notified of this activity as a part of the foundation's tax exempt application and that full disclosure of this activity was included in the administrative record that formed the basis of foundation's favorable tax exempt determination letter.

Foundation intends to correct the lease/rent structure that has given rise to the audit proposal before the first day of the tax year beginning in 2014.
