Project Access-Collin County (PACC) schedules medical services for qualified patients at 200% or below poverty level and who are without health insurance. Clients are referred to PACC by the county, participating hospitals, and volunteer physicians. PACC has helped 381 patients receive medical care with 185 active patients as of 12/2013. With 73% reporting, the PACC volunteer network delivered \$949,741 in medical care. The PACC staff secured \$188,610 in Pharmacy assistance and over \$88,000 for prescription benefits was paid out. With only 73% volunteer physicians reporting, PACC provided \$1,226,801 in medical services to the indigent in Collin County for 2013.
