STRENGTHENING THE TRENTON HEALTH TEAM TO BECOME A SAFETY-NET ACCOUNTABLE CARE ORGANIZATION - THE NICHOLSON FOUNDATION AWARDED THT AN 18-MONTH GRANT FROM SEPTEMBER 1, 2012 - FEBRUARY 28, 2014, TO ESTABLISH A CARE MANAGEMENT TEAM TO SUPPORT MEDICAID HIGH UTILIZING PATIENTS AND TO BUILD THE ORGANIZATIONAL INFRASTRUCTURE TO BECOME AN EFFECTIVE ACCOUNTABLE CARE ORGANIZATION THIS GRANT WAS EXTENDED FOR THREE MONTHS, TO COVER MARCH-MAY, 2014 TAKEN TOGETHER, THE GRANT ACTIVITIES GREATLY ENHANCED THT'S ABILITY TO BE READY FOR CERTIFICATION AS A MEDICAID ACO PROGRAM ACTIVITIES INCLUDED 1 ESTABLISHMENT OF A CARE MANAGEMENT TEAM (CMT) THT ESTABLISHED A CARE MANAGEMENT TEAM, CONSISTING OF A REGISTERED NURSE, LICENSED SOCIAL WORKER, AND TWO COMMUNITY HEALTH WORKERS THE CMT PROVIDED COMPREHENSIVE CARE MANAGEMENT INTERVENTIONS FOR A PILOT GROUP OF 45 MEDICAID AND CHARITY CARE RECIPIENTS WHO WERE HIGH-UTILIZERS OF EMERGENCY DEPARTMENT (ED) SERVICES (DEFINED AS MORE THAN 10 ED VISITS IN A YEAR) OR WHO WERE CONSIDERED HIGH-RISK BASED ON ONE OR MORE OF THE FOLLOWING PARAMETERS DIAGNOSIS OF DIABETES, MYOCARDIAL INFARCTION, PNEUMONIA, COPD, OR SICKLE CELL MORE THAN TWO (2) HOSPITALIZATIONS IN A 12-MONTH PERIOD A PREVIOUS 30-DAY HOSPITAL READMISSION FOUR (4) OR MORE MEDICATIONS A SUMMARY OF THE FINDINGS FROM THE CMT INTERVENTION INCLUDES THE FOLLOWING THT DID NOT HAVE ACCESS TO MEDICAID COST DATA, BUT FINANCE PERSONNEL AT THT'S HOSPITAL PARTNERS ADVISED US THAT MEDICAID REIMBURSEMENT LEVELS WERE ROUGHLY 20% OF HOSPITAL CHARGES USING THAT RATIO TO COMPARE THE COST OF DELIVERING THE INTERVENTION WITH THE PREDICTED REDUCTION IN TOTAL COST TO MEDICAID, THE CARE MANAGEMENT PROGRAM DEMONSTRATED A RETURN ON INVESTMENT OF 196% THE MEAN LENGTH OF INTERVENTION WAS 4 7 MONTHS WITH A STANDARD DEVIATION OF 1 6 MONTHS THE MEDIAN LENGTH OF INTERVENTION WAS FOUR (4) MONTHS, THE MAXIMUM LENGTH EIGHT (8) MONTHS AND THE MINIMUM LENGTH WAS TWO (2) MONTHS ED UTILIZATION DECREASED BY 4 6% FOR THE TOTAL COHORT, EMERGENCY DEPARTMENT CHARGES WERE REDUCED BY 24 2%, AND TOTAL HOSPITAL CHARGES WERE REDUCED BY 24 4% THE ANALYSIS IDENTIFIED THAT FOUR PATIENTS WHO WERE HIGH UTILIZERS SERVED IN THE COHORT HAD SICKLE CELL ANEMIA THESE INDIVIDUALS HAD SIGNIFICANTLY DIFFERENT UTILIZATION AND COST OUTCOMES FROM THE REST OF THE HIGH-UTILIZER COHORT EXCLUDING THE RESULTS FROM THOSE FOUR PARTICIPANTS, ED UTILIZATION FOR THE REST OF THE COHORT DECREASED BY 56 4%, ED CHARGES DECREASED BY 53 0%, AND TOTAL HOSPITAL CHARGES DECREASED BY 38 6% A NUMBER OF VARIABLES AFFECTED THE FINAL RESULTS THE LENGTH OF THE STUDY WAS SHORTER THAN EXPECTED BECAUSE OF DIFFICULTIES IN RECEIVING INITIAL REFERRALS FROM THE HOSPITALS THE HIGH PREVALENCE (98%) OF MENTAL HEALTH AND SUBSTANCE ABUSE CO-MORBIDITIES, AS DETERMINED FROM MEDICAL HISTORY AND ASSESSMENTS, ALSO LIMITED THE EFFECTIVENESS OF CMT INTERVENTIONS AS IT WAS OFTEN DIFFICULT TO CONNECT PATIENTS TO BEHAVIORAL RESOURCES IN THE COMMUNITY THE CMT HAD SIGNIFICANT DIFFICULTY OBTAINING SUBSTANCE ABUSE AND MENTAL HEALTH PLACEMENTS BECAUSE OF INSUFFICIENT OUTPATIENT AND/OR RESIDENTIAL DETOXIFICATION PROGRAMS IN THE CITY OR SUFFICIENT PROVIDERS WITH REQUISITE BEHAVIORAL HEALTH CREDENTIALS AS MENTIONED ABOVE, THT PROVIDED CARE MANAGEMENT SERVICES UNDER THIS GRANT BOTH FOR HIGH-UTILIZERS OF AVOIDABLE HOSPITAL SERVICES AND FOR PATIENTS WHO WERE MEDICALLY AT HIGH RISK FOR BECOMING HIGH-UTILIZERS IN THE FUTURE (SELECTED BY THE CLINICAL CRITERIA SPECIFIED IN THE GRANT AGREEMENT AND LISTED ABOVE) SUBSEQUENT COMMUNICATION BETWEEN THE NICHOLSON FOUNDATION AND THT DURING THE GRANT PERIOD REVEALED CONFUSION REGARDING THE INTENDED TARGET POPULATION FOR THE CARE MANAGEMENT INTERVENTION MOVING FORWARD UNDER THIS GRANT, THT'S CARE MANAGEMENT PROGRAM WILL SERVE ONLY MEDICAID BENEFICIARIES WHO ARE THE HIGHEST UTILIZERS OF AVOIDABLE HOSPITAL SERVICES KEY LEARNINGS TO INFORM FUTURE WORK INCLUDE THE FOLLOWING INITIAL OUTREACH AND ENROLLMENT EFFORTS TEND TO BE MORE SUCCESSFUL WHEN THEY OCCUR DURING OR IMMEDIATELY AFTER A HOSPITAL VISIT SUCCESSFUL REFERRAL PATTERNS ARE ESSENTIAL AND TAKE TIME TO BUILD CONNECTING PATIENTS TO
