Statement 1; Part III. Friends of the Avalon Volunteer Fire Department was formed in 2011. The purpose of the corporation is to: (a) be organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to first responder organizations within the Borough of Avalon, NJ that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. (b) engage in any and all lawful purposes, activities and pursuits, which are substantially similar to the foregoing and which are or may hereafter be authorized by Section 501(c)(3) of the Internal Revenue Code and are consistent with those powers described in the New Jersey Nonprofit Corporation and Cooperation Association Act, as amended and supplemented. (c) solicit and receive contributions, purchase, own and sell real and personal property, to make contracts, to invest corporate funds to spend corporate funds for corporate purposes, and to engage in any activity in furtherance of, incidental to, or connected with any of the other purposes.

Statement 2; Lines 10 and 28. Friends of the Avalon Volunteer Fire Department supported the operating expenses (\$176,008) of the Avalon Volunteer Fire Department providing resources for weekly drills and meetings, the purchase of equipment, procuring professional training instructors for seminars and workshops, convention expenses and professional shows specifically intended to enhance the skills of the Borough's firefighters. Also supported was the 100th Anniversary and Celebration of the Avalon Volunteer Fire Department, which was a community wide event.

Statement 3; Lines 10 and 29. The FAVFD also contributed to the final expenses (\$12,757) of the construction of the Borough of Avalon's 911 Memorial in the Borough Center, and supported (\$6,150) the completion of the Borough's "Pet Evacuation Trailer". The "PET" was an idea implemented to facilitate the evacuation of residents who might otherwise resist leaving the island in an emergency should there be no accommodation for their pets.

Line 16, 28a and 32 represent Friends direct mail fund raising costs and office expenses.
