Programs include workforce development, maritime and environmental education and training, youth internships, community clean-up and beautification projects, community gardens, disaster preparedness, cultural resources and community resources. Eligible applicants include community-based organizations, nonprofits, schools, educational institutions, training and career centers. Funding priorities aligned with HCBFs 2013-2016 Strategic Plan

HEALTHY HARBOR GRANTS Round 2 of HCBFs competitive health care program awarded six grants, ranging from \$17,500 to \$101,000, to organizations addressing community health impacts stemming from port operations. Eligible applicants include health care providers, clinics, institutions, community-based organizations, nonprofits, medical training and career centers. HCBF also hosted two annual community health fairs, with free tests, health screenings and referrals
