BTWF created its Born Brave Bus as a traveling safe space for young people During the bus tour it conducted extensive coalition building and forged strong partnerships with local and national organizations to support youth empowerment and engagement This outreach supported more than 30 such partnerships with groups helping young people Key national partners included the National Association of School Psychologists, GLSEN and youth Service America (YSA) These groups-plus Campus Pride, Hive, YOUmedia, MENTOR, Mentoring USA and The Trevor Project--supported BTWF at over 20 deployments across the country, reaching and interacting with more than 20,000 people in 2013

The Born Brave Bus Tour also collected survey research data in conjunction with the University of Nebraska-Lincoln, the National Council for Behavioral Health and the National Association of School Psychologists This unique partnership collected over 2,500 surveys from bus visitors aged 13-25 detailing their views on mental health services and delivery methods The resulting data was presented in two scholarly papers delivered at the American Psychological Association highlighting the discrepancy between existing mental health services and the types of services young people prefer([http //empowerment unl edu/blog/?p=297](http://empowerment.unl.edu/blog/?p=297))

BTWF's Youth Advisory Board (aka "YABers") engaged youth on the road and online, and drove the conceptualization, planning and execution of our work The Born Brave Bus Tour connected approximately 20,000 bus visitors with counselors/psychologists who spoke with young people about emotional empowerment, offering local resources for help with depression, bullying and other problems The National Council for Behavioral Health remains a dedicated partner in the effort to provide help BTWF also created a robust web and social media presence to de-stigmatize mental problems and force helpful connections, and planned expansion by brick and mortar partners to reach more youth
