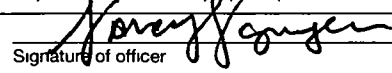

A total of 24 NGOs participated in these three locations. Volunteer staff performed field visits and due diligence reports for strategic partners. They traveled far and wide to Yunnan, Chengdu, Lanzhou, Xian, Guangxi, Henan, Vietnam, and Cambodia.
