### **PART III – STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENT**

**28. NicaPhoto After School Program** serves approximately 100 children and young people living in some of the poorest barrios in Nicaragua. The goal of the program is to provide the proper supports to increase school graduation rates. For two consecutive years NicaPhoto's elementary school graduation rate was 89%, well above the country average of less than 50%. The program expenses of \$29,643 include 90% of Nicaraguan Salaries.

**29. Scholarships** are provided for public school, private school and university students. Scholarships are base on need. Scholarships are given to make education accessible to even the most disadvantaged children and young people. The program expenses of \$8,459 include 10% of Nicaraguan Salaries.
