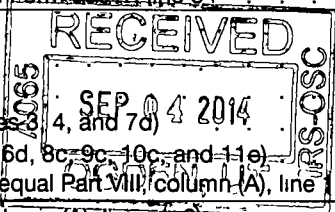

RallyPoint/6 identified a physical location that underwent a major renovation to establish a meeting place in the community that is a catalyst for military to connect to community and receive support as they transition and reintegrate. RallyPoint/6 received overwhelming support from the community in establishing the RallyPoint.

RallyPoint/6 was able to serve veterans and military families throughout the renovation. With 2 full time staff (including the CEO) and 4 full-time Veterans Leader Core AmeriCorps members, RallyPoint/6 was able to serve over 200 military members and their families with employment, education, housing, financial and benefit cases. RallyPoint/6 logged over 2200 volunteer hours and also collaborated with over 20 organizations within the community who have become permanent partners in supporting the mission. The State Department of Veterans Affairs has placed a FTE staff member and WorkForce Central has placed 2 full-time staff members at RallyPoint/6. In addition there are over 10 organizations that are dedicating staff to be physically located at RallyPoint/6 in support of education, housing, benefit and family program services. The mission also evolved from local community awareness; to an organization that is now nationally recognized as a leading best practices in the country.
