REST HOUSE In 2013, REST expanded the REST Restorative House from 2 to 6 beds The REST Restorative house is a long-term residential program for women aged 18-24 who have been trafficked for commercial sex or otherwise been involved with commercial sexual exploitation The housing program provides housing, case management services, education, life-skills classes, job training, limited medical and dental, transportation and fare, food, clothing, allowances, incentives, support, counseling, group therapy and more Residents can stay in the program for up to two years at no cost to the resident In 2013, REST provided housing for 7 women The expense includes all program, payroll and employee benefits for one full-time Residential Program Manager and one full-time Case Manager, as well as one full-time Residential Advocate who was hired during 4th quarter 2013

OTHER PROGRAM In 2013, REST provided training and awareness to more than 350 community members through our REST Training Day This training included the dynamics of the sex trade, both locally and nationally, as well as how REST seekds to engage and serve this populations and the sex-trafficking problem in Seattle, WA Many of the people who have attended our training go on to serve as a volunteer with REST Others who have attended training go back to other cities and states to start their own anti-trafficking organization In addition, REST provided additional training to high schools, colleges and other groups interested in learning more about domestic commercial sex We have also added a second day of training for those interested in becoming mentors

ADVOCATES In 2013, REST engaged 361 girls and young women in Seattle's sex trade We met these girls through direct outreach (street, jail and bikini barista outreach), through our 24-hour hot line, as well as through various referral agencies In 2013, REST had 182 on-going client relationships Many of these relationships included case management services, connecting clients to various needed resources throughout the country, primarily locally In addition, other clients were connected to REST Mentors to facilitate on-going regular supportive community Through our advocate teams, clients received counseling support, transportation, housing referrals, educational assistance, as well as meeting basic felt needs such as food, hygiene supplies and clothing In several cases, young women were connected to jobs or paid internships In 2013, REST was recognized by Seattle Met Magazine's Light a Fire Award as Seattle's best nonprofit organization, "Most With The Least" This award was given to Seattle's best organization making the most amount of impact with the least amount of resources Finally, Boeing Employees Credit Union name REST's Chief Operating Officer, Bridget Battistoni, as Volunteer Member of the Year and awarded REST a \$15,000 grant for her work's local impact Across all of REST's various teams, we have more than 80 volunteers
