ALTHOUGH THE WARS IN AFGHANISTAN AND IRAQ HAVE BEEN RAGING SINCE 2001 AND 2003, RESPECTIVELY, THE DEPARTMENT OF DEFENSE AND THE VETERANS ADMINISTRATION HAVE JUST RECENTLY BEGUN TO ADDRESS THE SIGNATURE WOUND OF THESE CONFLICTS, TRAUMATIC BRAIN INJURY (TBI).
