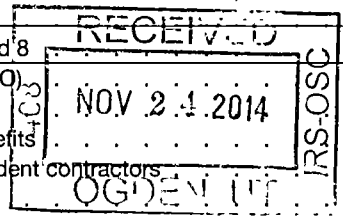

Twenty client/participants were provided with Situational Assessments and Work Skills and Behavior Training in our Computer Refurbishing program. The organization provided job placement services for forty-three individuals.
