

SEVERAL GRANTS TO STANFORD'S BIOMATERIALS AND ADVANCED DRUG DELIVERY LAB (BIOADD) TO EXPLORE NOVEL APPROACHES TO ERRADICATING BORRELIA BURGDORFER.
