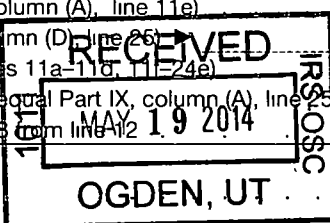

Western Native Voice strives to strengthen Native American communities in Montana and surrounding regions by engaging and empowering Native Americans (on reservations and in urban areas) to participate in the civic process and the decisions that affect their lives through community outreach, voter education, leadership development and public policy advocacy.

Voter Education. The most significant element of our 2013 program work focused on voter engagement and education efforts with Native Americans across Montana. Native culture is plagued with misinformation and mistrust of government processes which leads to very few potential voters being registered to vote and even fewer potential voters engaged and educated about public policy issues under debate on all levels. We devote time and resources to building relationships and trust with Natives and educating them about the mechanics of our democratic process and their rights and responsibilities within it.

4b (Code:) (Expenses \$ 65,144 including grants of \$) (Revenue \$)
Policy and Advocacy: We provided advocacy services on a range of policy issues from protecting voter rights to securing the future of Native culture in Montana. We helped found a ballot committee composed of a coalition of nonprofit organizations concerned about proposed legislation that would further disenfranchise voters through the repeal of Montana's same-day voter registration process.
We advocated for the establishment of satellite voting stations located closer to rural Native voters. As the system exists now, many of Montana's Native voters have to commute an hour or more to reach their polling location, a significant impediment for voters without available transportation or adequate time and resources to devote to the voting process.
We advocated for the establishment of the Montana Indian Language Preservation Program to ensure that Native language and culture are not lost with the elder generation.
We also advocated for tribes seeking to re-establish bison on tribal land. Bison are central to the history and culture of the Plains Indians and, as such, are deeply connected to Native identity. Re-establishing bison on Montana's plains would also further efforts to preserve a threatened species.

Leadership Development & Capacity Building: We hosted two major training events in 2013 focused on developing leadership skills and improving understanding of the democratic process. We encourage our constituency to become leaders in their communities and in their elected government, using their perspectives and cultural values to empower and engage their friends, family and neighbors in the civic process. We also advocate for improving education and medical services in Montana's Native communities through cooperation between sovereign tribal governments, the state of Montana, and the Native Americans who are most closely impacted.
