THE ORGANIZATION FOLLOWED A "RAISING A READER PROGRAM" WHICH WAS A BIG SUCCESS. IT'S A NATIONALLY RENOWNED PROGRAM WHICH CONSISTED ROTATING BOOKS SENT HOME ON A WEEKLY BASIS. EACH STUDENT BROUGHT HOME A BAG OF BOOKS FOR THE WEEK TO READ WITH THEIR FAMILIES. EACH BAG CONTAINED FOUR BOOKS.
