990 part VI Section B question 11b. The treasurer prepares the tax return from the financial records, and from information provided by
other board members and employees. The financial results are discussed at board meetings, and the completed form 990 and attachments
are sent to board members for their review prior to filing.

990 part VI Section B question 12c. All board members are given a board book which includes the conflict of interests policy. Periodically
the policy is discussed and inquiry is made of each member if they are aware of any such conflicts. None have been raised. Further,
the Treasurer is aware of the small number of vendors paid by the organization, and he is aware of no such conflicts.

990 part VI Section C question 19. The governing documents, including the articles of incorporation, the bylaws, conflict of interest
policy, financial statements and tax returns are available on request at the offices of the organization during regular business hours.
