

Part I, Line 10: Project Pearl has three main program expenses: 1) Providing medical care and foster home for homeless animals who would not otherwise be able to enter the adoption program at Forsyth County Animal Control; 2) Support Community-Wide Spay/Neuter Initiatives and sponsor adoptable animal's spay/neuter fees to increase adoptions and reduce euthanasia of healthy animals at Forsyth County Animal Control; and 3) Educate the community about the importance of spay/neuter and make them aware of the animals available for adoption at Forsyth County Animal Shelter. 132,860 of the 136,433 expended in 2013 went directly to one of these three areas.

Part I, Line 16: Other Expenses includes a fee to the NC Dept of Secretary of State for a by-law change. The rest is credit card processing fees to 3rd party credit card processing company who processes Project Pearl online contributions.

Part IV: Project Pearl is entirely volunteer run.
