During the past year the Brigance Brigade Foundation was able to create a greater awareness to ALS through a variety of media exposures - the greatest being a 10 minute feature on O J Brigance that aired numerous times on ESPN during the Baltimore Ravens Super Bowl run. The Foundation has also provided grant support to a number of families to help and assist with their request to enhance their family members quality of life. Among those receiving grants from the Foundation resulted in a donation of a wheelchair which enabled the family to travel to Disneyworld; the purchase of a DynaVox communication device which now allows the ALS family member to continue to communicate with her family and friends, the installation of a porch-lift which now allows an ALS patient to not be confined to his home; and funding to support 24 hour home health care so a family can gain back some financial stability.
