In 2013, TAA granted accreditation to 23 facilities following a thorough and rigorous process whereby each organization agreed to maintain a set Code of Standards reviewed and approved by the American Humane Association and the American Association of Equine Practitioners. Each facility was subject to an in depth application and received onsite vists to each facility caring for their horses. In 2013, these approved facilities received grants totaling \$1,000,000 and these grants may be used only for activities, materials, supplies, and services directly related to the care of the organization's horses.


