The Indy Hunger Network created a grant program to provide funds to Pantry Partner pantries and other hunger relief agencies for capacity-building projects. The Pantry Partners are striving toward a five-point vision: Access, Nutrition, Capacity, Referrals, Education. Three pantries received funding totaling \$64,733.

The growth and sustainability of the private (non-profit) suppliers of food assistance depends on their ability to raise funds. Early work by the network determined that across the board there was opportunity for improvements in this area. Based on this, the Indy Hunger Network contracted with an experienced professional fundraising consulting firm to execute development audits for four of the non-profits who had never had a development 'audit.' Development audits serve as a road map for making improvements to fund raising. This work began in 2013 and will conclude in 2014. A parallel series of grants will be made in 2014 for those non-profits who already had a development audit for implementation of a key element of their road map. These projects should significantly aid the partners as they work to increase their sustainability.

The Indy Hunger Network supports children getting access to the Federal Summer Food Service program via an awareness campaign throughout Marion County. We branded the program Summer Servings in 2011. We produced marketing materials for sponsors and serving sites. We work with local media and IndyGo for advertising opportunities. The goal of this initiative is to increase participation in the Summer Servings program throughout Marion County. The total number of lunches served in 2013 increased by more than 40,000 vs. 2012 despite the summer being substantially shorter due to school calendar changes.
