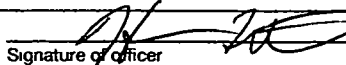

Deaf Can was awarded a grant from the Alcohol and Drug Abuse Division under Minnesota Department of Human Services to provide sober housing and support services to persons who are Deaf or Hard of Hearing and recovering from substance use disorders.

The program model aims to help the client to maintain stabilization of biological, psychological and social functioning in the community; to promote a positive lifestyle; and solidify the gains accomplished in treatment. The design of the project is to find safe and sober supportive housing in the community and hire qualified Sober Coaches to provide housing support services for deaf adults 18 years or older who have completed primary treatment from the Minnesota Chemical Dependency Program for Deaf and Hard of Hearing Individuals (MCDPDHHI). The grant is \$126,000 per fiscal year and is used primarily for facility, equipment and staff expenses. Sober coaches will provide instruction covering communication skills, community resource utilization skills, relapse prevention skills, employment skills, health care management and basic living skills.

Outcome measures reported to state will focus on housing stability; increased skills or income; and greater self-determination.
