Omidyar Fellows - The Omidyar Fellows is a leadership development program for emerging leaders in the state of Hawaii. It launched in April 2012 with statewide recruitment and outreach for its first round of applicants. Ninety-seven applications from interested candidates were received, and of those, fifteen were chosen to participate in the inaugural cohort of the program. For the next 15 months, the Omidyar Fellows followed a curriculum that developed leadership on individual, group and community levels, using program elements that include executive coaching, peer and cohort learning, leadership conversations and an out-of-state learning excursion.
