DURING 2013, THE PAC FOCUSED ON BUILDING THE TEAM TO DEVELOP THE ARTISTIC PROGRAM SUCH THAT THE PAC BUILDING IS BEING DESIGNED TO BEST SUPPORT A PREFERRED PROGRAM. THE KEY MEMBER OF THE TEAM JOINING IN 2013 WAS DAVID LAN AS CONSULTING ARTISTIC DIRECTOR. DAVID HAS BEEN THE ARTISTIC DIRECTOR OF YOUNG VIC IN LONDON SINCE 2000. UNDER DAVID'S LEADERSHIP, THE YOUNG VIC HAS BECOME ONE OF THE MOST CELEBRATED THEATERS IN EUROPE, MAJORING IN INTERNATIONAL COLLABORATION AND LOCAL COMMUNITY. AT THE SAME TIME, DAVID HAS ALSO ESTABLISHED SEVERAL AWARDS TO RECOGNIZE NEW TALENT. IN ADDITION TO RUNNING THE YOUNG VIC THEATERS, DAVID LEAD THE DESIGN AND RENOVATION THE BUILDING, NAMED RIBA LONDON BUILDING OF THE YEAR IN 2006. DAVID HAS RECEIVED COUNTLESS ADDITIONAL ACCLAMATIONS FROM THE LONDON AND NEW YORK PRESS, CRITICS AND INDUSTRY COLLEAGUES. CHARCOALBLUE ALSO JOINED THE PAC TEAM IN 2013 AS THEATER CONSULTANT. CHARCOALBLUE IS THE LEADING THEATER CONSULTING FIRM IN THE UK, AND OPENED A NY OFFICE IN 2012 TO WORK ON NUMEROUS PROJECTS IN THE US WORKING WITH THE PAC TEAM, CHARCOALBLUE HAS DEVELOPED CONCEPTUAL DRAWINGS THAT WILL RESULT IN PRODUCTION OPPORTUNITIES LIKE NO OTHER IN NYC. LUCY SEXTON JOINED THE PAC TEAM AS ARTISTIC PROGRAM CONSULTANT. LUCY IS A FORMER DANCER/PERFORMER WHO HAS A WIDE AND DEEP KNOWLEDGE OF THE PERFORMING ARTS WORLD AND ESPECIALLY DOWNTOWN, AND EXTRAORDINARY CONTACTS IN THE CITY WITH ARTISTS, PERFORMERS AND PRODUCERS. LUCY HAS SERVED AS DIRECTOR OF THE NEW YORK DANCE AND PERFORMANCE AWARDS, THE BESSIES SINCE 2010. LUCY HAS WORKED TO MAKE SURE THE PAC TEAM MEETS WITH THE NYC PERFORMANCE COMMUNITY TO IDENTIFY GAPS AND NEEDS THAT ARE NOT CURRENTLY BEING MET WITHIN THE LOCAL AREA. THE DIRECTOR STEPHEN DALDRY JOINED THE BOARD TO OVERSEE THE OVERALL PLANNING FOR THE ARTISTIC PROGRAM AND THE BUILDING. ONE OF STEPHEN'S MOST ACCLAIMED WORKS IS DIRECTING BILLY ELLIOT, BOTH THE MOVIE AND THE MUSICAL, WHICH HAS WON 76 THEATER AWARDS INTERNATIONALLY. STEPHEN'S MANY RECOGNITIONS INCLUDE SIX OLIVIER AWARDS, TWO TONY AWARDS AND NUMEROUS ACADEMY AWARD NOMINATIONS. HE WAS ALSO THE ARTISTIC DIRECTOR OF THE ROYALTY COURT THEATRE AND OVERSAW ITS EXTENSIVE RENOVATION.
