

The following are the major accomplishments in 2013 by SLI in its mission to equip and resource SLCDO.

1) Robin Gordon provided teacher training to Shining Light Academy in Gilgit, Pakistan between May 20 - June 21 and Oct 1 to Oct 30, 2013.

The school provides quality, English medium education to 321 students from Pre-School to Class 6 with a teaching staff of 20.

2) Mike Gordon implemented Total Quality Management to SLCDO staff for continuous improvement of services to meet customer needs.

Employees were trained May 20 - June 21 and Oct 1 - Oct 30. Facilitated organization/leadership development initiatives and completed several key admin procedures with staff training. SLCDO has 45 employees that all benefit from this training.

3) SLI provided over \$2000 to SLCDO to support capacity building/leadership development programs on 2 separate occasions: May 20 - June 21 and Oct 1 - Oct 30 (see above).

4) SLI provided over \$8500 to implement Phase 1 of the Empowerment for Life Project to train 45 women from the Women's Vocational Training Center (WVTC) in Gilgit, Pakistan. The WVTC provides cutting, sewing, knitting, embroidery and wool weaving training to low income women in order to provide job skills training. Yobel International provided entrepreneurial, quality control and fashion design training to launch our new Life Stitch Manufacturing Center that will employ local women to produce clothing, accessories & handicraft items for local, national and international sales. Over 300 women have received job skills training through the WVTC & are ready to work. Yobel International introduced several accessory items and placed the first order for international wholesale of products.

5) SLI provided \$3000 to SLCDO to support the Education Scholarship Program. The Scholarship program provides books, tuition, uniforms and all school fees to over 125 Christian migrant, minority children from low income background. These children are particularly vulnerable and come from low income families where education is not affordable.

6) SLI provided \$3500 to SLCDO to support the Remote Village Development Program where 517 children from 4 remote villages are receiving an education including uniforms, supplies, tuition and all fees. SLI also provides funding for 7 teachers that assist in the 4 villages. It should be noted that 150 girls are receiving an education for the first time in village history.
