AFTER A YEAR OF RESEARCH AND DEVELOPMENT, NORTHERN PLAINS EYE FOUNDATION (NPEF) LAUNCHED NORTHERN PLAINS EYE FOUNDATION WESTERN SOUTH DAKOTA LIONS CHILDREN'S VISION SCREENING INITIATIVE (CVSI), WITH A GOAL OF MAKING VISION SCREENINGS ACCESSIBLE TO MORE CHILDREN, LEADING TO EARLY DETECTION, TIMELY DIAGNOSIS AND APPROPRIATE INTERVENTION THROUGH A UNIQUE PARTNER-SUPPORTED STRATEGY, NPEF AND LOCAL LIONS CLUB VOLUNTEERS TRAINED IN THE USE OF NEW TECHNOLOGY, OFFER FREE CHILDREN'S VISION SCREENINGS AT DAYCARES, PRE- SCHOOLS AND ELEMENTARY SCHOOLS. COMPREHENSIVE SCREENING RESULTS ARE DOCUMENTED AND MAILED TO PARENTS OF CHILDREN SCREENED, WHICH INDICATE EITHER NO FOLLOW-UP IS REQUIRED, OR A COMPLETE EYE EXAM IS RECOMMENDED, AS (TEXT EXCEEDS SPACE ALLOWED - CARRIED OVER TO SCHEDULE O) WELL AS WHY THE CHILD IS BEING REFERRED TO AN EYE CARE PROFESSIONAL. IN THE CASE OF CHILDREN WHO REQUIRE A COMPLETE EYE EXAM, ADDITIONAL INFORMATION IS PROVIDED AS TO THE MEANING OF CONDITIONS IDENTIFIED ON THE SCREENING RESULT, EYE CARE PROFESSIONALS IN THE REGION AND AGENCIES THAT MAY PROVIDE ASSISTANCE TO FAMILIES IN NEED. WHEN THE CHILD RECEIVES AN EYE EXAM, AN EVALUATION FORM IS PROVIDED TO THE EYE CARE PROFESSIONAL, WHICH THE EYE CARE PROFESSIONAL IS ASKED TO COMPLETE AND RETURN TO NPEF. IN OUR FIRST YEAR OF CVSI, WHICH BEGAN IN MAY 2012 WITH A PILOT SCREENING AND CONCLUDED IN MAY 2013, WE SCREENED 1759 CHILDREN, EXCEEDING OUR GOAL, WHICH WAS TO SCREEN 1000 CHILDREN. LONG-TERM, OUR STRATEGY IS TO EXPAND CVSI STATE-WIDE THROUGH PARTNERSHIPS WITH THE EYE CARE INDUSTRY, DONORS AND BUSINESSES IN ORDER TO SUSTAIN THIS IMPORTANT AND WORTHWHILE INITIATIVE

SINCE ITS INCEPTION, 20 SIGHT-SAVING SURGERIES HAVE BEEN PROVIDED THROUGH CHRISTMAS GIFT OF SIGHT, HELPING THOSE UNDERSERVED IN OUR COMMUNITY REGAIN THEIR VISION, AND MOST IMPORTANTLY, INDEPENDENCE, MOBILITY AND QUALITY OF LIFE

NPEF'S HEALTH-CARE EDUCATION SCHOLARSHIP PROGRAM WAS DEVELOPED IN 2005 IN RECOGNITION OF THE NEED FOR FUTURE HEALTH AND EYE CARE PROFESSIONALS IN OUR REGION. SCHOLARSHIPS WERE INITIALLY AWARDED TO UNDERGRADUATE STUDENTS PURSUING FULL-TIME HEALTH-CARE RELATED STUDIES. SINCE THE PROGRAM'S INCEPTION, NPEF HAS AWARDED FIFTY-TWO SCHOLARSHIPS TOTALING 73,000 TO RECIPIENTS IN ITS 5-STATE SERVICE AREA. FOLLOWING A PROGRAM EVALUATION IN 2012, NPEF MADE A DECISION TO CHANGE THE FORMAT OF THE SCHOLARSHIP PROGRAM FROM GENERAL HEALTH CARE TO A FORMAT FOCUSED MORE DIRECTLY ON IMPACTING THE GROWING NEED FOR EYE CARE PROFESSIONALS. BEGINNING IN 2013, THROUGH AN AGREEMENT WITH THE UNIVERSITY OF SOUTH DAKOTA FOUNDATION, NPEF PLEDGED TO (TEXT EXCEEDS SPACE ALLOWED - CARRIED OVER TO SCHEDULE O) GIVE 7,500 IN SCHOLARSHIP AWARDS (1,500/SCHOLARSHIP/YEAR) TO FOURTH YEAR STUDENTS WITH AN EXPRESSED INTEREST IN OPHTHALMOLOGY OR OPTOMETRY, WHO HAVE BEEN ACCEPTED INTO THE SANFORD SCHOOL OF MEDICINE. THE SCHOLARSHIP, NAMED THE NORTHERN PLAINS EYE FOUNDATION DR. PAUL L. ZIMMERMAN MEMORIAL SCHOLARSHIP, IS AWARDED TO A RECIPIENT FROM NPEF'S SERVICE AREA, WHICH INCLUDES SOUTH DAKOTA, AND PARTS OF NORTH DAKOTA, NEBRASKA, WYOMING AND MONTANA
