1 OFFICE OF ECONOMIC EDUCATIONThe Thomas R Brown Foundation (TRBF) continues its work with the Office of Economic Education (OEE) at the University of Arizona in providing outreach programs. TRBF and OEE continue to offer the microeconomic and macroeconomic workshops, which have been so popular since the beginning, taught by award-winning professors and classroom teachers. Additionally, TRBF/OEE now provides undergraduate education majors with professional development offerings in economics. Finally, as part of the strategic plan, TRBF/OEE staff have successfully established reliable contacts in the five southern Arizona counties outside of Pima County to assist in building a network with local community colleges, county school superintendents, and district administrators to develop a teaching talent network in southern Arizona.	84,025
2 ECONOMICS BOOK CLUBThe TRBF Economics Book Club is comprised of teachers who research and select six books each year with economic themes, then meet to discuss the economic issues explored in the books. This highly participatory and interactive program allows teachers to clarify, expand and deepen their knowledge of economic principles by reading broadly through the discipline. Participation in the book club allows teachers to incorporate richer substance and high-level content into their classrooms. The book club meets every other month throughout the school year and the Foundation facilitates the meetings. Each book is discussed for two consecutive nights to accommodate the large group of teachers who participate. During 2013 there was a participatory headcount of 40 teachers.	12,263
3 V O T E (Voices on the Economy) SeriesThe series is designed to provide a better base for understanding civic and government activities by increasing the understanding of how economic principles affect political outcomes without attempting to promote or criticize any specific political viewpoint. During the summer, Dr. Amy Cramer teaches a foundational three-day workshop that introduces teachers to the three economic perspectives and how these economic perspectives effect the political action taken on topics such as rent control, minimum wage, consumer regulations and agricultural subsidies. These economic perspectivesconservative, liberal and radicalappear both historically and in contemporary political discourse. As a sequel to the foundational Markets and Government course taught during the summer, Dr. Cramer has developed a series of topic-based workshops that apply the same economic perspectives to modern political issues such as business cycle stabilization policy, income inequa	40,303
4 LEADERSHIP CADRE TRAININGThe purpose of this program is to develop a cadre of well-qualified teachers who can take a leadership role in economics education. This represents the second round of leadership training. The first training took place in 2007. The 2013 training was provided to a group of 12 teachers who show promise as economic leaders. While not all of the teachers in the 2007 training transitioned into leadership roles, the program unquestionably developed several economics teachers into leaders who have paid forward the benefits they received through the training. Their original training continues to pay dividends for TRBF as the leaders assist with the Book Club, the online Econ University, and were presenters at six TRBF workshops / roadshows during 2013.	13,387
