THE PROGRAM FOCUSES ON COLLABORATIONS WITH LOCAL SCHOOLS TO PRODUCE WORKSHOPS WITH CHILDREN. THE PROGRAM IS ESSENTIAL TO THE CULTURAL EXCHANGE THE FOUNDATION PROMOTES. ADDITIONALLY, ARTISTS HAVE THE OPTION OF STAGING AN EXHIBITION, DISCUSSION, PERFORMANCE, OR SCREENING FOR THE COMMUNITY. THESE EVENTS ALSO ARE BROADCAST ONLINE TO AN INTERNATIONAL NETWORK THAT REACHES A BROAD AUDIENCE AROUND THE WORLD. IN 2013, THE FOUNDATION'S ARTISTS-IN-RESIDENCE WERE ARTEMIO AND MAXIMO GONZALEZ, AND KENNY SCHARF.

TO DATE 1,150,000 SEA TURTLES OF 4 SPECIES HAVE HATCHED ON CAREYES BEACHES AND MADE IT SAFELY TO THE OCEAN. ?! CAREYES FOUNDATION IS LENDING SUPPORT TO THIS EFFORT.
