(RAU-Africa).

RAU-America has provided this Grant to RAU-Africa to build a Guest House and Bible Training Center on 12 acres of land

purchased by RAU-Africa. Future Grants from RAU-America will be used to build an Orphan Care Center, Christian Day

RAU-Africa is not controlled by RAU-America. RAU-Africa has three Board of Directors two of which are Ugandan citizens

and Christian Ministers. The third board of director is the President of RAU-America, Jacob Lee

RAU-America has sent, Jacob Lee, to Uganda as a full time missionary to ensure that RAU-Africa provides periodic accountings to show

how RAU-America's grant funds were expended for the purposes in which they were approved by RAU-America's Board

of Directors and he keeps and maintain records, expenses reports, and receipts showing that grants made by RAU-America have been made

and used for RAU-America's exempt purposes.

This Grant is subject to strict review of RAU Board of Directors following procedures and policies set for in RAU-America's By-Laws.
